In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Precious Metal Company of Florida Inc.

ARTICLE II

The existence of the corporation shall begin on February 1, 1997.

ARTICLE III

The street address of the principal office of the Corporation is 4630 South Kirkman Road, Suite 194, Orlando, Florida 32811.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100,000 (One Hundred Thousand), all of which shall be Common Shares. 
ARTICLE VII

ARTICLE VIII


The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
