

ARTICLES OF INCORPORATION
OF

Article I.

Name.

The name of this corporation is **DIAMOND COMPUTER TECHNOLOGIES INC.** Its address is 7731 Old Floral City Road, Suite 1, Floral City, FL 34446-0296

Article II.

Purpose.

This corporation is organized for the purpose of transacting any or all lawful business.

Article III.

Capital Stock.

This corporation is authorized to issue One Thousand (1,000) shares of One Dollar (\$1.00) par value common stock.

Article IV.

Preemptive Rights.

Every shareholder, upon the sale for cash or any new stock of this corporation of the same kind, class or series as that which he (she) already holds, shall have the right to purchase his (her) prop rata share thereof (as nearly as may be dome without issuance of fractional shares) at the price at which it is offered to others.

The approval of the shareholders of this corporation to any such plan of merger shall be required in every case, whether or not such approval is required by law.


Article XI



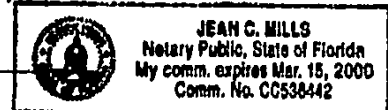
