ARTICLES OF INCORPORATION  
OF  
DUANE PEACHEE CONSTRUCTION, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is DUANE PEACHEE CONSTRUCTION, INC.

ARTICLE II - DURATION

This corporation shall have a perpetual existence, commencing on March 1, 1997.

ARTICLE III - PURPOSES

The general purposes for which this corporation is organized are to engage in the construction, repair and remodeling of buildings and public works of all kinds, and for the improvement of real estate, and the doing of any other business and contracting work incidental to or connected with such work, including demolition.

The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from engaging in any lawful act or activity for which a corporation may be organized under the General Corporation Law of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one thousand (1,000) shares of \$1.00 par value common stock, which shares shall be of a single class.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which the shareholder already holds, shall have the right to

#### ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

#### ARTICLE VIII - INITIAL BOARD OF DIRECTORS



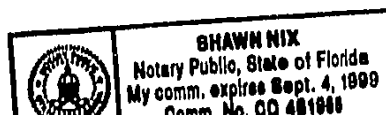
