The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

AMERICAN DATA INTRANET SERVICES, INC.

The address of the principal office of this corporation shall be 1800 Northwest 65th Avenue, Plantation, Florida 33313, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS
