The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is: Great Southern Shows, Inc. and the principal address of this corporation is 1222 Shackleton Road, Jacksonville, FL 32211.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and/or all lawful business.

ARTICLE IV - CAPITAL SHARES

The aggregate number of shares which the corporation shall have authority to issue shall be Five Hundred (500) Shares of Common Stock, having a nominal par value of \$ 1.00 per share.

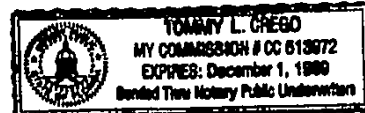
