ARTICLES OF INCORPORATION

OF

MURANO DUE, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporations is: $\ensuremath{\mathsf{MURANO}}$ $\ensuremath{\mathsf{DUE}}$, $\ensuremath{\mathsf{INC}}$.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purpose. The general purposes of which the Corporation is organized are the following:
