ARTICLES OF INCORPORATION
OF
ARBOR HOMES, INCORPORATED

The undersigned subscribers or incorporators to the Articles of Incorporation, each a natural person competent to contract, do hereby form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is
ARBOR HOMES, INCORPORATED.

ARTICLE II - DURATION

This corporation is to exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for all purposes authorized under the laws of the United States and the State of Florida

ARTICLEIV-CAPITAL STOCK

The total number of shares which the corporation is authorized to issue at this time is One Hundred (100) shares. Such shares shall be of a single class and shall have a par value of One Dollar (\$1.00). The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than 35 person. Stock will be issued and transferred only to (1) natural persons, (ii) estates, or (iii) a trust defined in Section 1361 (c)(2) (or its successor section) of the Internal Revenue Code. In addition, no stock shall be issued or transferred to a nonresident alien.

ARTICLEV-TRANSFER OR SALES OF SHARES

5.01 In case a shareholder desires to transfer or sell his or her shares of stock, he or she must first offer them for sale to the remaining shareholder(s). Likewise, in the event of the death of a shareholder, the remaining shareholder(s) shall have the right to purchase the shares of a deceased shareholder from that person's estate. Any transfer of shares in violation of this provision is null and void.

5.02 In the event that the selling shareholder and the purchasing shareholder cannot agree on a valuation of the shares to be sold, each shall select a person of their choice to be and appraiser; the two appraisers shall select a third appraiser; and the three appraisers shall by majority vote determine a valuation for the shares. The purchasing shareholder shall have

fourteen (14) days to purchase the shares at the appraised value, or the right of purchase shall be forfeited.

ARTICLEVI-INITIAL CAPITAL

The amount of capital with which this corporation will begin business shall be not less than One Hundred Dollars (\$100.00).

ARTICLEVII-INITIAL OFFICE

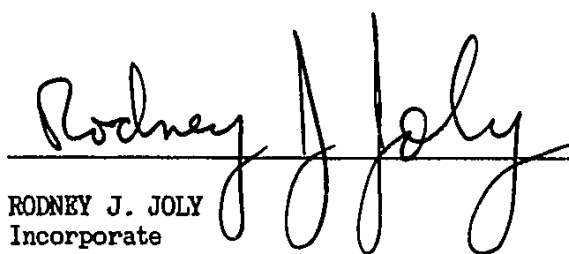

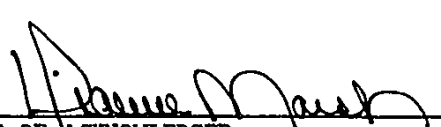
ARTICLEIX-BOARD OF DIRECTORS

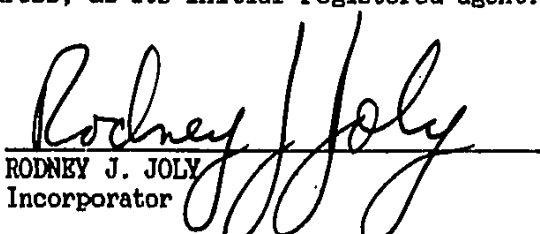

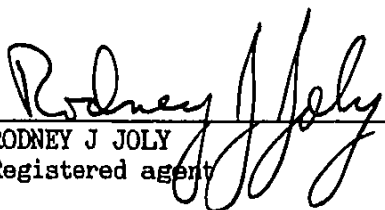
