The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

Article I - Name

The name of this Corporation is BLR, INC. The principal place of business of this Corporation shall be 4519 George Road, Suite 110, Tampa, Florida, 33634, or such other place as may be designated by the Board of Directors.

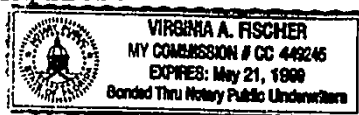
