ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 607.1003 of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

1. The name of the Corporation is BLR, INC.
2. The following amendment to the Articles of Incorporation was adopted by the Shareholders of the Corporation on the 4th day of June, 1998 in the manner prescribed by the Florida Business Corporation Act:

Article I, titled "Name," is hereby amended to read as follows:

Article I

Name

The name of the Corporation is PAYDAY NOW OF FLORIDA, INC.

3. The shares of the Corporation issued and outstanding at the time of adoption was Two hundred (200) shares and the number of shares entitled to vote thereon was Two hundred (200).

4. The number of shares voted in favor of such amendment was Two hundred (200) shares and the number of shares voted against such amendment was zero (0).

5. The number of votes cast by the Shareholders of the Corporation in favor of the foregoing Amendment to the Articles of Incorporation was sufficient for approval.
