# Articles of Incorporation of Garage Doors, Incorporated

#### Article I. - Name

The name of this corporation is Garage Doors, Incorporated

#### Article II. - Duration

This corporation shall exist into perpetuity.

#### Article III. - Purpose

This corporation is organized for the following purposes: to engage in sale, installation and servicing of new and used garage doors and for any other lawful corporate purpose.

#### Article IV. - Capital Stock and Voting Rights

This corporation is authorized to issue 10,000 shares of common stock at \$1.00 par value, which shall be designated "Common Shares", and is authorized to issue initially 100 shares at \$1.00 par value, which shall fully paid for at the time of incorporation. Therefore, the initial capitalization of 100 shares shall be non-assessable.

This corporation shall initially have only one class of stock.

Except as otherwise provided by law, the entire voting power for all purposes shall be vested exclusively in the holders of the outstanding shares.

#### **Article V. - Preemptive Rights**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which is offered to others.
