ARTICLE I

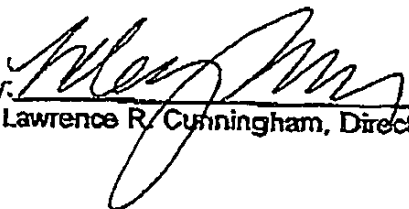
CORPORATE NAME
