ARTICLE I: NAME

The name of this corporation is Boca Auction Gallery, Inc. The mailing address of the corporation is 11 S.E. 3rd Street, Boca Raton, Florida 33432.

ARTICLE II: DURATION

This corporation shall have perpetual existence.

ARTICLE III: PURPOSE


