ARTICLE I

NAME

The name of this corporation is Drayt Investments, Inc.

ARTICLE II

PRINCIPAL OFFICE

CAPITAL STOCK

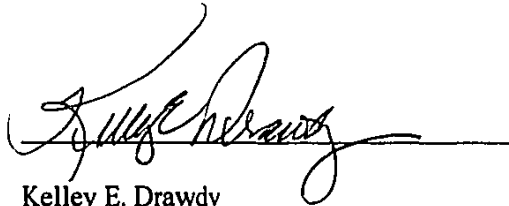

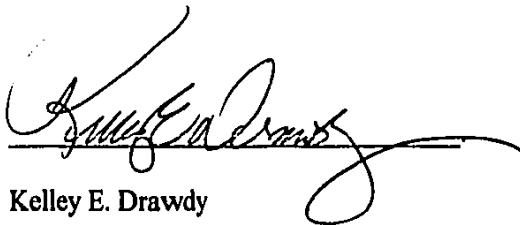
