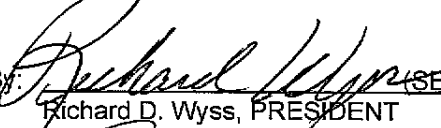
1. The former name of the corporation is Pestban of the Emerald Coast, Inc., a Florida corporation.

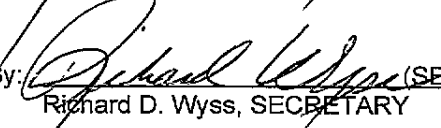

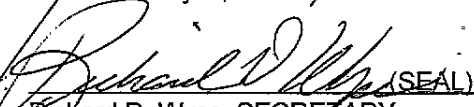

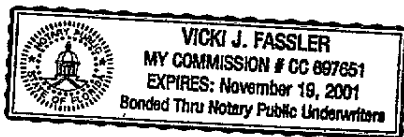
