ARTICLES OF INCORPORATION

We, the undersigned, subscribers to these Articles of Incorporation, each a natural person competent to contract, do hereby associate ourselves to form a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation is Fowler's Maintenance, Inc.

ARTICLE II

The purpose of the corporation is to provide commercial janitorial Service. The corporation may also engage in any lawful transactions in the State of Florida and the United States.

ARTICLE III

This corporation shall have perpetual existence.

ARTICLE IV

The amount of capital with which this corporation shall begin business is five-hundred Dollars (\$500.00).

ARTICLE V

The maximum number of shares that this corporation is authorized to have outstanding at any one time is five hundred (500) shares of common stock having a nominal or par value of One and No/100 Dollars (\$1.00) per share.

ARTICLE VI

The registered agent shall be Walter A. Fowler. The registered office and principal office is to be 1708 Sagasta Street Tampa, Florida 33619. The Board of Directors may, from time to time, designate such other post office address and place for the principal office of this corporation as it may see fit.

ARTICLE VII

The number of Directors of this corporation shall never be less than one (1). The number of Directors may be increased or diminished from time to time, By-Laws adopted by the stockholders, but shall never be less than one (1).

ARTICLE VIII

ARTICLE IX

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholders' meeting by a majority of stock entitled to vote thereon, unless all the Directors and all the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.


ARTICLE X

(1) Any action taken by the Directors of this corporation, or by members of an Executive Committee of the Directors of this corporation, without a Special Meeting shall never-the-less be Board or Committee action if written consent to the action in question is signed by all the Directors or Members of the Committee, as the case may be, and filed with the Minutes of the proceedings of the Board of Directors, whether done before, or after the action to be taken.

(2) Any action of the stockholders of this corporation may be taken without a meeting consent in writing, setting forth action so taken, shall be signed by all the persons who would be entitled to vote upon such action at a meeting and filed with the Secretary of the corporation as part of the corporate records. Such consent shall have the same force and effect as the unanimous vote of the stockholders and may be stated as such on any certificate or documents.

(3) Stock to be issued pursuant to these Articles of Incorporation shall be issued under the terms, provisions and conditions of Section 1244 of the Internal Revenue Code.

I hereby am familiar with and accept the duties and responsibilities as registered agent for said corporation.

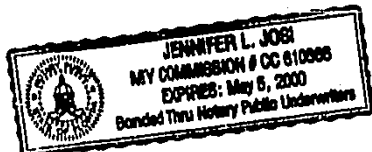
