ARTICLE I. NAME AND ADDRESS: The name of the Corporation is ALLIANCE TRANSLATING SERVICES, INC., and it's principal office and mailing address is 1564 N.E. 191ST Street, #319, North Miami Beach, Florida 33179.

ARTICLE II. REGISTERED AGENT AND ADDRESS: The Registered Agent is DARLI O. BARBOSA, and the initial registered office of the Corporation is 1564 N.E. 191ST Street, #319, North Miami Beach, Florida 33179.

ARTICLE III. TERM OF CORPORATE EXISTENCE: The Corporation shall exist in perpetuity unless dissolved according to law and such existence shall commence at the time of the filing of these Articles of Incorporation by the Secretary of State of the State of Florida.


