Article I - Name

The name of this corporation shall be: MERCA INTERNATIONAL FREIGHT, INC.

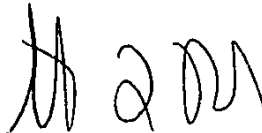

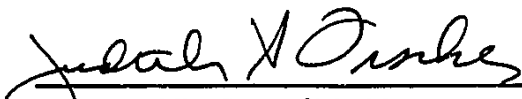
