### ARTICLES OF INCORPORATION

OF

### LASER STORM OF PENSACOLA, INC.

The undersigned, acting as incorporator of Laser Storm of Pensacola, Inc., under the Florida General Corporation Act, adopts the following Articles of Incorporation.

## ARTICLE I. NAME AND ADDRESS

The name of the corporation is:

## ARTICLE II. COMMENCEMENT OF EXISTENCE

(a) To transact any or all lawful business for which a corporation may be incorporated under the Florida General Corporation Act.

# ARTICLE IV. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 500 shares of common

stock having a par value of \$.01 per share. The consideration to be paid for each share shall be fixed by the board of directors and may be paid in whole or in part in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation, with a value, in the judgment of the directors, equivalent to or greater than the full par value of the shares.

## ARTICLE V. PREEMPTIVE RIGHTS

Each holder of common stock of this corporation shall have the first right (subject to adjustments to avoid the issue of fractional shares) to purchase shares of common stock of this corporation that from time to time may be issued (whether or not presently authorized), including shares from the treasury of the corporation, in the ratio that the number of shares of common stock held at the time of the issue bears to the total number of shares of common stock outstanding. This right is waived by any holder of common stock who does not exercise it and pay for the stock preempted within thirty days of his receipt of a written notice from the corporation inviting him to exercise the right.

## ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT


