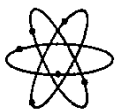

ARTICLE I - NAME

The name of this corporation is FIRETRONICS TECHNOLOGY, INC., located at 499 State Road 434, Suite 1053, Altamonte Springs, Florida 32714.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing upon the filing of these Articles of Incorporation, which shall be the effective date of this corporation.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business which corporations may conduct pursuant to the laws of the State of Florida.

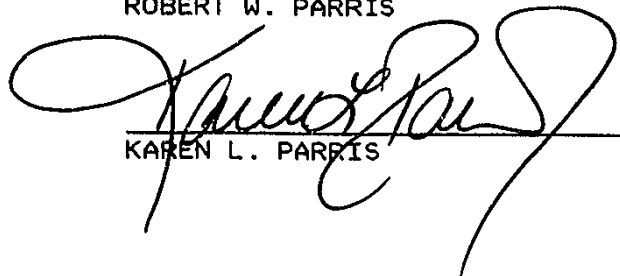
