**ARTICLES OF INCORPORATION
OF**

ALACHUA COUNTY EXCEL CENTER, INC.

The undersigned subscriber to the Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLES I. NAME

The name of the corporation shall be:

ALACHUA COUNTY EXCEL CENTER, INC.

The principal place of business of this corporation shall be 502 NW 75th Street, Suite 144, Gainesville, FL 32607.

ARTICLES II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the Laws of the United States, the State of Florida or any other state, country or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 500 shares of common stock having \$1.00 par value per share.

ARTICLE IV. ADDRESS

The street address of the initial registered office of the corporation shall be 502 NW 75th Street, Suite 144, Gainesville, FL 32607 and the name of the initial registered agent of the corporation at that address is Richard A. Kendzior.

ARTICLE V. BOARD OF DIRECTORS

The business affairs of this corporation shall be managed by the Board of Directors. This corporation shall have three Directors initially. The number of Directors may be increased or decreased from time to time, by the By Laws.


