ARTICLES OF INCORPORATION

OF

ARTICLE I

NAME AND ADDRESS

The name of this corporation is DRIFTWOOD LANDSCAPE & MAINTENANCE, INC. and its principal address is 5051 Tamiami EFFECTIVE DATE Trail North, Naples, Florida 34103.

ARTICLE II

DURATION

This corporation shall exist perpetually commencing on the date of execution of these Articles of Incorporation.

ARTICLE III

PURPOSE
