

#### ARTICLES OF INCORPORATION

OF

#### ARTICLE I

In the event that the Company shall fail or refuse to redeam such shares within ninety days following the tender thereof to the Company, then and in that event, the person to whom such shares were originally issued shall be authorized to dispose of such shares or any part thereof in any manner permitted by law.
