**ARTICLES OF INCORPORATION
OF
FIVE STAR WATER TREATMENT
CORPORATION, SOUTHEAST FLORIDA**

The undersigned, being a natural person of legal age, does hereby desire to form a corporation under the laws of the State of Florida and do hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of the Corporation shall be FIVE STAR WATER TREATMENT CORPORATION, SOUTHEAST FLORIDA and the business address and location of the Corporation shall be 705-D West State Road 434, Longwood, Florida 32750.

ARTICLE II

CORPORATE DURATION

This Corporation shall commence to exist on the execution of these Articles of Incorporation. The duration of the Corporation is perpetual.
