**ARTICLES OF CORRECTION

The undersigned Corporation, in accordance with Section 607.0124 of the Florida Business Corporation Act, hereby files the following Articles of Correction and states:

1. The name of the Corporation is **METROPOLITAN RADIO GROUP OF FLORIDA, INC.**

2. These Articles of Correction are to the Articles of Incorporation of **METROPOLITAN RADIO GROUP OF FLORIDA, INC.** (the "Articles of Incorporation") filed with the Department of State on February 13, 1997.

3. Article X of the Articles of Incorporation contained an incorrect statement indicating that corporate existence was to commence as of the date of filing of the Articles of Incorporation when in fact the intention of the Corporation was to commence corporate existence within five (5) business days prior thereto.

4. Article X of this Corporation's Articles of Incorporation is hereby corrected so as to read as follows:


**"ARTICLE X**


