SECOND ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

TER IS PROPERTY

OF

CYPRESS CREEK MASONRY, INC.

ARTICLE IX of the Articles of Incorporation shall be amended by deleting the existing Article IX in its entirety and substituting in its place the following:

"ARTICLE IX - OFFICERS AND DIRECTORS
