WE THE UNDERSIGNED, hereby associate ourselves for the purpose of becoming a corporation under the Laws of the State of Florida.

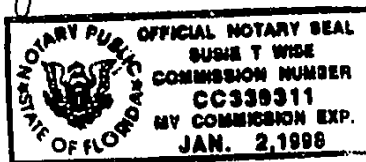
