The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida. 97 FEB 10 PM 1:32 ALL/IN/ST/FLORIDA

ARTICLE I

Name: The name of the corporation is Hideaway Imports, Inc.
