**ARTICLE I - Name**

The name of this corporation is **THE SENIOR PRO-BASS TOURNAMENT TRAIL, INC.** The mailing address and the principal place of business shall be 87 14th St. BHR, Okeechobee, Florida 34974.

**ARTICLE II - Duration**

This corporation shall exist in perpetuity, commencing on the date of execution and acknowledgment of these Articles.

**ARTICLE III - Purpose**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV - Capital Stock**

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.

**ARTICLE V - Pre-emptive Rights**


**ARTICLE IX - Bylaws**
