**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator under and by virtue of the Laws of the State of Florida and particularly, The Florida General Corporation Acts, as provided in Chapter 607, Florida Statutes, and any acts supplementary thereto, adopts the following Articles of Incorporation for such corporation.

ONE: The name of the corporation is: Paul's Tailors, Inc.

TWO: The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of the State of Florida, other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the State of Florida.

THREE: This corporation is authorized to issue only one class of shares of stock which shall be designated common stock. The total number of shares it is authorized to issue is Five Hundred (500) shares. Par value of stock will be \$1.00 (one dollar) per share.

FOUR: The number of directors of the corporation shall be a minimum of one (1) and not more than fifteen (15), none of whom shall be required to be stockholders, nor to be residents of the State of Florida. The names and addresses of the persons who are appointed to act as the initial directors of the corporation who, subject to the provisions of the Certificate of Incorporation, By-Laws of the Corporation, and the Laws of the State of Florida, shall hold office for the first year of the existence of the Corporation or until their successors are duly elected and qualified, are as follows:

FIVE: The liability of the directors of the corporation for monetary damages shall be eliminated to the fullest extent possible under the laws of the State of Florida.

SIX: The corporation is authorized to indemnify the directors and the officers of the corporation to the fullest extent permissible under the laws of the State of Florida.

SEVEN: The location of its initial registered office in the State of Florida is: 3113 Bayview Drive Ft Lauderdale, Florida, but it shall have the power to establish and maintain branch offices at such cities and towns in the State of Florida and the United States as said corporation may from time to time determine. The name of its initial registered agent is Leopoldo F. Totera. The principal address of the office shall be the same as the above address.

EIGHT: The term of existence of the corporation shall be perpetual.
