ARTICLES OF INCORPORATION OF  
CUSTOM DECKS, INC.

2/10/97

1. Name. The name of the corporation is: CUSTOM DECKS, INC.
2. Purpose. The corporation may engage in any legal business.
3. Stock. The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 1,000 shares of common capital stock of a par value of \$1.00 per share. The corporation shall have a lien on its shares of stock for any debt or liability incurred to it by a stockholder before being notified of the transfer or levy on such shares.
4. Existence. The corporation shall have perpetual existence. The corporation shall commence existence on February 10th, 1997.
5. Registered Agent. The initial street address in the State of Florida of the initial registered office of the proposed corporation is 14489 N.W. Highway 19, Chiefland, Florida 32626 and the name of its initial registered agent at such address is D. H. Luce.
