

FIRST AMENDMENT TO ARTICLES OF INCORPORATION OF S.T.P. PROPERTIES CORPORATION

Pursuant to Florida Statutes Section 607.1003 *et seq.*, Hamby Hutcheson, as president of S.T.P. Properties Corporation, a corporation organized under the laws of the State of Florida on February 13, 1997 Document #P97000014519 (the "Corporation"), hereby makes, swears, certifies and files the following First Amendment to the Corporation's Articles of Incorporation, which amendment has been adopted by one hundred percent (100%) of the shareholders of the corporation, at a duly noticed meeting of the shareholders held on July 14, 1997, pursuant to a duly authorized recommendation of the Board of Directors. The amendment is effective as of July 14, 1997.

1. **Change of Name.** The name of the Corporation is hereby amended to be "Check.Net Communications, Inc."
2. **Nature of Business.** Article 2, concerning the nature of the business to be conducted, is hereby amended to read as follows: "The general nature of the business to be transacted will be the provision of computer design and consulting services, and all related activities."

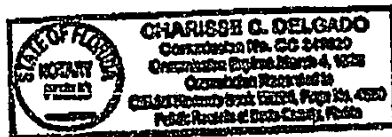
