ARTICLES OF INCORPORATION

OF

AVTEAM AVIATION FIELD SERVICES, INC.

a Florida Corporation



ARTICLE I.

NAME

The name of this corporation is AVTEAM Aviation Field Services, Inc. and its mailing address is 3230 Executive Way, Miramar, Florida 33025.

ARTICLE II

NATURE OF BUSINESS

This Corporation is being formed for the following purposes:

- a. To engage in any and all lawful business or activity permitted under the laws of the United States, the State of Florida and the State of Texas.
- b. To generally have and exercise all powers, rights and privileges necessary and incident to carrying out properly the objects herein mentioned.
- c.
