## ARTICLES OF INCORPORATION OF RENAISSANCE MOTOR CARS, INC.

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I

EFFECTIVE DATE

#### Corporate Name and Principal Office

The name of this corporation is RENAISSANCE MOTOR CARS, INC. and its principal office and mailing address is 10112 Lindelaan Dr., Tampa, Fl. 33618.

#### **ARTICLE II**

#### Commencement of Corporate Existence

The corporation shall come into existence on February 7, 1997.
