The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

STATE OF FLORIDA

ARTICLE I

NAME: The name of the corporation shall be **PAB Sales & Marketing Strategies, Inc.**
