ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Managed Care of Argentina, Inc. and its address is 999 Ponce de Leon Boulevard, Suite 940, Coral Gables, Florida 33134.

DURATION

The duration of the corporation is perpetual.
