## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION MEMORY GARDENS, INC.

Pursuant to the provisions of Chapter 607, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, filed February 5, 1997, #P97000014848.
