

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

### **ARTICLE I NAME**

The name of the corporation is RealTime Commerce Solutions, Inc.

### **ARTICLE II PRINCIPAL OFFICE**






