AMENDMENT TO ARTICLES OF INCORPORATION
OF
HARRIS & ASSOCIATES CREATIVE DEVELOPMENT, INC.

Pursuant to the provisions of Section 607.0806, Florida Statutes, this corporation, HARRIS & ASSOCIATES CREATIVE DEVELOPMENT, INC., adopts the following Articles of Amendment to its Articles of Incorporation, filed with the Secretary of State for the State of Florida on February 17, 1997, as Document Number P97000015033:

The Articles of Incorporation are amended by adding the following new Article VII, Issuance of Shares:

"ARTICLE VII: ISSUANCE OF SHARES

"Shares of stock of this Corporation, whether issued (i) in exchange for services, property or other capital contribution, or (ii) otherwise, shall only be issued upon approval of the holders of seventy-five percent (75%) or more of the then issued and outstanding shares of voting stock of this Corporation. This Article may only be amended or revoked by a like percentage of the issued and outstanding shares of voting stock of this Corporation."

These Articles of Amendment were approved by the Stockholders of the corporation April 28, 1997. The number of votes cast for the Articles of Amendment by the Stockholders was/were sufficient for approval.
