The name of the corporation shall be amended to: **Dark Horse Tavern, Inc.**

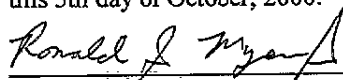

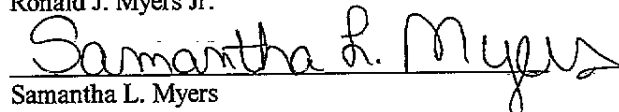
