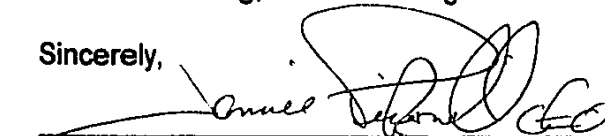

ARTICLE IV

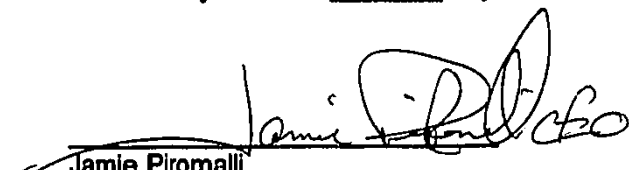

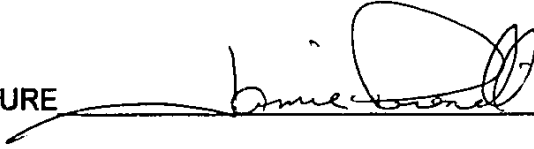
