OF

The undersigned does hereby certify his Intention to form a corporation under and by virtue of the laws of the State of Florida, and further certifies that:

## ARTICLE I

The name of this corporation shall be: INTERNATIONAL FOOD CONSULTING, INC.

## ARTICLE II TERM OF EXISTENCE

This corporation is to exist perpetually.

### ARTICLE III NATURE OF BUSINESS

The general nature of the business or businesses to be transacted under this Certificate of Incorporation shall be:

The purchase, sale and production of food and food products, including restaurants, shops, distributorships, catering services and manufacturing; consultation and research regarding restorative food and food products; consulting and research regarding data processing, including the purchase and sale of hardware and software; consulting and research regarding marketing and fiscal and social resources; conducting and promoting public entertainment activities; and to engage in any activity or business permitted under the laws of the United States and of the State of Florida and to carry out

said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country.

#### ARTICLE IV **AUTHORIZED SHARES**

- A. Number. The aggregate number of shares that the corporation shall have the authority to issue is Ten Thousand (10,000) shares of Capital Stock with a par value of One (\$1.00) Dollar per share.
- B. Initial Issue. One Thousand (1,000) shares of the Capital Stock of the corporation shall be issued for cash at a par value of One (\$1.00) Dollar per share.

- E. No classes of stock. The shares of the corporation are not to be divided into classes.
- F. No share in series. The corporation is not authorized to issue shares in series.
