**ARTICLES OF INCORPORATION
OF
INSULFORM WALL SYSTEMS, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the Corporation shall be: **INSULFORM WALL SYSTEMS, INC.**



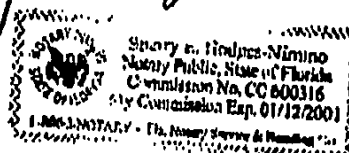
