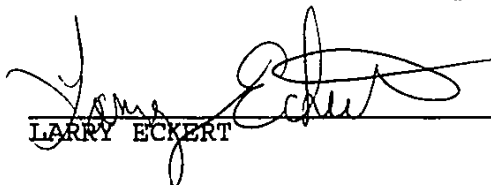

ARTICLE IX - Idemnification

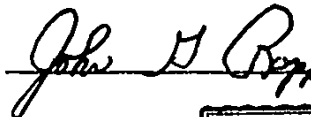

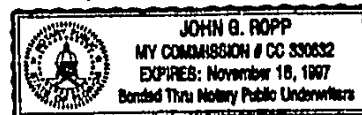

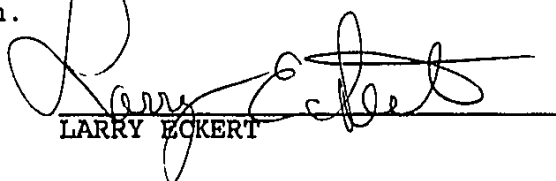
