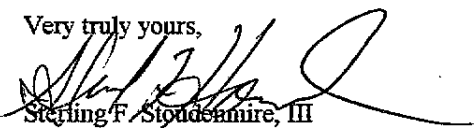
Thanks for your help in this matter. Mrs. Cox advises that she has discussed this matter with you.
