#### ARTICLE I \* NAME AND ADDRESS

The name of this corporation is Boshell Growers, Inc. and its principle place of business shall be at 11809 S.W. Fox Brown Road, Indiantown, FL 34956.

# **ARTICLE II \* DURATION**

This corporation is to exist perpetually.

# **ARTICLE III \* PURPOSE**
