ARTICLE I

NAME

The name of the Corporation is Larry Phillips Unlimited, Inc. The principal office address and the mailing address of said Corporation is 12154 Springmoor One Court Jacksonville, Florida 32225.

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III

PURPOSE
