# CERTIFICATE OF INCOMPORATION

OF

OTERS OF STATIONS

#### AFRICAN FOOD PLUS INC.

WE, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida providing for the formation of a corporation for profit, with the powers, rights, privileges and immunities hereinafter mentioned, and we hereby make, subscribe and acknowledge and file with the Secretary of State of Florida this Certificate of Incorporation; and to that end we'do, by this Certificate, set forth:

## ARTICLE I

The name of this corporation (which is hereinafter called the "Corporation") is:

AFRICAN FOOD PLUS INC.

### ARTICLE II

The general nature of the business and the objects and purposes to be transacted and carried on are to do any and all things allowed and permitted to be done by corporations under the Statutes of the State of Florida, and to do any and all of the things hereinafter mentioned as fully and to the same extent as natural persons might or could do, to-wit:

(a)

GROCERIES AND FOOD PRODUCT

- To subscribe for, invest in, purchase or otherwise acquire, to own, hold, sell, exchange, pladge or otherwise dispose of, securities of every nature and kind, including, without . Hmitation, all types of stocks, bonds, debentures, or obligations or avidences of indebtedness or ownership or participation issued or created by any and all associations, trusts or corporations. public or private, whether created, established or organized under the laws of the United States, any of the States, or any territory or district or colony or possession thereof, or under the laws of any foreign country, and also foreign and domestic government and municipal obligations, bank acceptances, commercial paper and secured call loans; to pay for the same in cash or property or by the issue of Atock, bonds or notes of this Corporation or otherwise and while owning or holding any such securities, to exercise all the rights, powers and privileges of a stockholder or owner, including the right to transfer and convey the said stock or other securities to one or more persons, firms, associations or corporat: subject to voting trusts or other agreements placing in such perso voting or other powers in respect of said stocks or other securitito borrow money or otherwise obtain credit and to secure the same ! mortgaging, pledging or otherwise subjecting as security the asset of this Corporation.
  - (c) To build, erect, construct, purchase, hire or other wise acquire, own, provide, establish, maintain, hold, work, devel sell, convey, lease, mortgage, exchange, improve and otherwise deal in and dispose of real estate and real property and all other kinds of property of whatsoever nature, whether real, personal or mixed, or any interests or rights therein without limits as to amounts; to buy, sell, assign, convey and cancel liens upon personal property and real estate of every kind and nature whatsoeve:

and secure the same by mortgage on its property or otherwise; to issue on commission, subscribe for, take, acquire, hold, exchange and deal in shares, stocks, bonds, obligations or securities of any government or authority, individual or corporation.

- (d) To carry on the business of a holding company and to purchase and acquire any mercantile or commercial husiness, trade or enterprise permitted by the laws of the State of Florida, and to own, hold, operate, maintain, use, sell, or otherwise dispose of the same; to enter into or engage in any such business, trade or enterprise.
