ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is J & B CONSTRUCTORS, INC.

ARTICLE II - DURATION

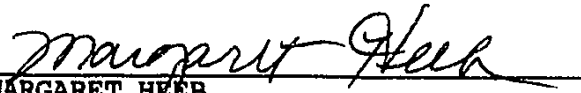
ARTICLE IX - INDEMNIFICATION

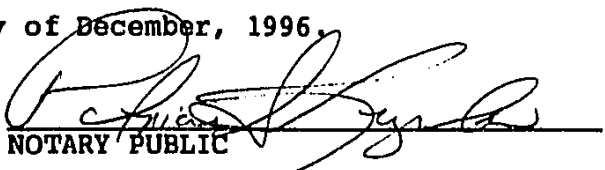
