I am enclosing an original 2009 FOR PROFIT CORPORATE REINSTATEMENT which I have signed as President of SouthSearch, Inc.


Apparently, we were notified by your office that our original annual report fee of \$150.00 was returned by our bank because on non-sufficient funds. Unfortunately, we did not receive this notice and, consequently, received a notice of administrative dissolution in January of this year. At the time your notice was sent, we were and still are in negotiations, the end result being a merger of SouthSearch, Inc. with another Florida corporation. Why, in the midst to this intense negotiation procedure, we didn't receive the notice, is unknown.

Upon receipt of the notice of administrative dissolution, we contacted your office and were told to send a money order in the amount of \$165.00 which we were told was the required payment in the notice we didn't receive. Enclosed is such a money order.

Because of this inadvertent oversight on our part, we would respectfully request that SouthSearch, Inc. be reinstated as a corporation in good standing in this state without having to pay the much larger fee of \$900.00. You will recall that you and I spoke earlier this month regarding reinstatement of this corporate to good standing with your office. For purposes of refreshing your recollection and to summarize the pertinent facts, I am enclosing the following:

1. Letter dated January 9, 2009 from Catherine Chin notifying of the administrative dissolution of the corporation.
2. My letter of March 25, 2009 explaining what had happened and transmitting payment of the 2008 annual fee.
3. Letter dated March 31, 2009 from Kathy Ashton demanding the fees stated in the letter to gain reinstatement.

The letter of March 31 is what prompted my call to you questioning the amount of the fees.
