ARTICLE FIVE

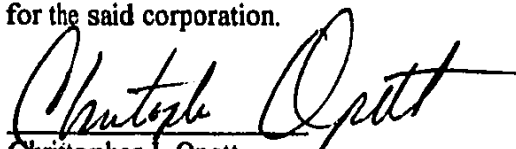

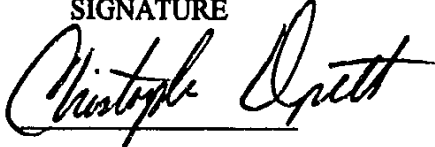
